

3. Photo Copy of PAN/TAN of the registered/Reputed firm/supplier/dealer/telecom company/ proprietor are required.
4. If the quotationer is not a registered telecom company, then he can provide the Authorized Dealership Certificate as firm/supplier/dealer/proprietor/franchise for that specific Telecom Company.

2. Quotation paper will be send through Post/By hand addressing to the **Principal Govt. ITI, Kotpad, At/Po- Kotpad, Dist- Koraput, Pin-764058 on or before 18.12.2024 at 10:00 A.M.**
3. Type of Communication, back up for uninterrupted supply of link, proper plan/tariff rates with connectivity ratio, Connection Interface, Maintenance charges per Year/Month etc. should be mentioned properly in the quotation.
4. Compensation on lost connection period(s) should be provided by the firm/supplier/telecom company accordingly.

6. Dedicated IP minimum 02 nos. are required for in the name of this institution.

8. Minimum 100 nos. of computer systems are to be operated.


